FBK became a participant of the UN Global Compact Local Network in Russia in August 2018, which affirms its commitment to the UN Global Compact principles and the UN Sustainable Development Goals.

This means that FBK's strategy is aimed to integrate the firm in the global sustainability processes, extend the potential of Russian business and society in contributing to the global agenda and improve investment prospects of the Russian economy. The firm is actively involved in the operation of the UN Global Compact Local Network. FBK's Partner Vladimir Skobarev was elected to the governing board of the UN Global Compact Local Network Association.

It should be noted that FBK promotes the SDGs for them to be integrated into strategies of Russian companies. The firm provides over 30% of all nonfinancial assurance services in Russia.



In addition, the firm contributes to the development of sustainability standards. In particular, Vladimir Skobarev participated in the development of the new revision of AA1000 AccountAbility Principles Standard (2018), and regularly speaks at events organised by UNCTAD's Intergovernmental Working Group of Experts on International Standards of Accounting and Reporting dedicated to companies' reporting on their contribution to the SDGs.

In 2022, FBK was included in the list of verifiers of sustainable finance instruments prepared by VEB.RF, Russia's national economic development institution. FBK is the only audit firm certified as a verifier of green financial instruments.

Human Rights

FBK respects, protects and upholds internationally accepted human rights, and is governed by the Russian Labour and Civil Codes of the Russian Federation, Constitution of the Russian Federation, and other laws and regulations that comply with international human rights and freedoms standards

The Corporate Code of Conduct and other internal documents adopted by the firm contain fundamental provisions intended to protect the dignity and freedom of each and every person

The Corporate Code is binding for the management and all employees of FBK, who undertake to abide by its provisions while interacting with colleagues, clients, business partners, public officials and the society on the whole

There have been no discrimination or human rights violation cases registered for over 30 years of operation

Local regulations provide for social guarantees and benefits to employees in addition to those granted by the current legislation. In particular, they provide for guarantees of working conditions, sick leave payment, payment for education, voluntary health insurance, cell phone reimbursement, allowances in certain cases, anniversary and other bonuses, work-related compensation

Decent Work

The FBK audit and consulting group is widely known in Russia and abroad for high quality audit, effective consulting and toprated legal defence services, as well as commitment to social responsibility.

The firm does not restrict employees' right to organise unions or initiate collective bargaining, does not use child labour, forced or compulsory labour and has zero tolerance for any discrimination.

FBK is always open to any suggestions from personnel and ready for dialogue with any employee, regardless of their position. Our firm has no pronounced hierarchy or division into managers and subordinates. Each employee can express a personal opinion, which will be factored into the general HR strategy.

FBK knows how to combine principles of democratic management and professional ethics. Employees can benefit from flexible working hours, but have to follow strict rules obliging them to observe deadlines set by clients.

The HR Department has generated an employer value proposition, which includes various options to satisfy key needs of our employees. This means stable salary, bonuses, voluntary health insurance allowing family members to join, an opportunity to choose between work in a comfortable modern office in the historical centre of Moscow or remote work, a corporate laptop and cell phone. The firm pays particular attention to corporate wellbeing. Since 2022, internal news has been communicated to employees in a corporate digest sent out twice a month. It has a special section about events and educational programmes.

In addition, we give employees a chance to develop their soft skills at the expense of the firm and receive training with partial or full reimbursement by the firm. Employees can take part in corporate events, including sports competitions.

In February 2022, FBK became a finalist of the all-Russian rating 2021 as an attractive and open employer with good HR processes and corporate image.

FBK's specialists are active members of the sustainability expert community with extensive experience in sustainable development and non-financial reporting. Since 2019, the firm has been arranging free of charge sustainability webinars, which are open to the general public.

Corporate culture and non-monetary motivation were established by involving the firm's personnel. The HR Department conducted several pulse surveys to measure employee loyalty index, identify advantages of working for the firm and understand employees' expectations about their education and development, as well as to analyse changes in sentiments among personnel caused by internal and global trends.

All FBK's offices are equipped with water purification systems, waste bins for separate collection of batteries, plastic and paper, and energy efficient appliances. Lightbulbs and car tyres are disposed through specialised companies In 2022, the FBK audit and consulting group continues to support environmental initiatives:

We draw attention to the problem of plastic bags at corporate sustainability seminars and encourage choosing reusable eco-friendly bags
